1 Amend the Education Committee Report, dated March 17, 2022, page 3,
2 line 11, strike ""two"" and substitute ""Two"" and strike ""two THREE".
3 and substitute ""Two THREE".

4 Page 6, line 25, strike "26," and substitute "26 OR".

5 Page 12, line 37, strike "27." and substitute "27 and substitute:

6 ~~(HH) Any applicant, licensee, or employee of the applicant or~~
7 ~~licensee who meets the definition of a department employee or an~~
8 ~~independent contractor, as those terms are defined in section 27-90-111,~~
9 ~~or who works for a contracting agency, as defined in section 27-90-111,~~
10 ~~and who will have direct contact with vulnerable persons, as defined in~~
11 ~~section 27-90-111 (2)(e), is required to submit to a state and national~~
12 ~~fingerprint-based criminal history record check in the same manner as~~
13 ~~required pursuant to section 27-90-111 (9); except that the state~~
14 ~~department shall not bear the cost of such criminal history record check~~
15 ~~required by this subsection (7)(a)(HH). The state department may also~~
16 ~~conduct a comparison search on the Colorado state courts public access~~
17 ~~system to determine the crime or crimes for which the individual having~~
18 ~~direct contact with vulnerable persons was arrested or convicted and the~~
19 ~~disposition of such crime or crimes. The criminal history record check~~
20 ~~required by this subsection (7)(a)(HH) must be submitted to the state~~
21 ~~department prior to the individual having direct contact with vulnerable~~
22 ~~persons, and an applicant, licensee, or employee of an applicant or~~
23 ~~licensee must not be allowed to have direct contact with vulnerable~~
24 ~~persons if he or she does not meet the requirements set forth in this~~
25 ~~subsection (7) and in section 27-90-111 (9)."~~

26 Page 17, strike lines 20 through 23 and substitute:

27 "(XVI) THE DEPARTMENT OF EARLY CHILDHOOD IN SOLICITING
28 AND SELECTING ENTITIES TO SERVE AS LOCAL COORDINATING
29 ORGANIZATIONS PURSUANT TO SECTION 26.5-2-103 AND COORDINATING
30 AGREEMENTS ENTERED INTO PURSUANT TO SECTION 26.5-2-105."."

31 Page 18, line 18, strike "services or" and substitute "services, or".

32 Page 18, line 19, strike "department" and substitute "department, OR THE
33 DEPARTMENT OF EARLY CHILDHOOD,".
