18 for the 2025-26 fiscal year are:

20 (1), C.R.S., up to a maximum of ~~\$100,000,000~~ **\$60,000,000;**

21 (h) Up to ~~\$39,775,000~~ **\$79,775,000** of state properties as follows:

22 (I) The capitol annex building located at 1375 Sherman Street,  
23 Denver, Colorado, 80203, which has a value of ~~\$28,225,000~~  
24 **\$68,225,000;** and

25 **SECTION 13. Amend as added by Section 1 of House Bill**  
26 **26-1410,** (2)(c), (2)(h) introductory portion, and (h)(I) as follows:

27 "Section 1. **Definitions - general provisions.** As used in this act,  
28 the following definitions and general provisions shall apply:

29 (2) The funds designated to constitute the state emergency reserve  
30 for the 2026-27 fiscal year are:

31 (c) The marijuana tax cash fund created in section 39-28.8-501  
32 (1), C.R.S., up to a maximum of ~~\$100,000,000~~ **\$60,000,000;**

33 (h) Up to ~~\$53,337,711~~ **\$93,337,711** of state properties as follows:

34 (I) The capitol annex building located at 1375 Sherman Street,  
35 Denver, Colorado, 80203, which has a value of ~~\$37,237,711~~  
36 **\$77,237,711;** and".

37 Renumber succeeding section accordingly.
