- 1 Amend printed bill, page 12, strike lines 18 through 27 and substitute:
2 "(7.5) A LARGE-SCALE TRANSPORTATION NETWORK COMPANY
3 SHALL NOT CHARGE A FEE OR INCREASE THE COST OF A".
- 4 Page 13, strike lines 1 through 3.
- 5 Page 13, strike line 5 and substitute "RECORDING OF A PREARRANGED
6 RIDE."
- 7 Page 13, lines 9 and 10, strike "CONDUCTED PURSUANT TO SUBSECTION
8 (7.5)(a) OF THIS SECTION," and substitute "OF EACH PREARRANGED RIDE,".
- 9 Page 13, strike lines 13 through 27 and substitute:
10 "(B) THE ABILITY FOR DRIVERS TO OPT IN TO AUDIO AND VIDEO
11 RECORDING FOR EACH PREARRANGED RIDE AND THE CADENCE FOR
12 AUTOMATICALLY OPTING IN DRIVERS;
13 (C) THE ABILITY FOR RIDERS TO OPT IN TO AUDIO AND VIDEO
14 RECORDING FOR EACH PREARRANGED RIDE;
15 (D) ON-DEVICE RECORDING DELETION CAPABILITIES AND
16 RESTRICTIONS;
17 (E) ACCESS TO, OWNERSHIP OF, STORAGE OF, ENCRYPTION OF, AND
18 RETENTION PERIODS FOR AUDIO AND VIDEO RECORDINGS, CONSIDERING
19 THE CAPABILITIES AND LIMITATIONS OF IN-USE TECHNOLOGY AND
20 INCLUDING MEASURES TO PROMOTE VICTIM-SURVIVOR PRIVACY AND
21 CHOICE;
22 (F) NOTIFICATIONS TO DRIVERS AND RIDERS OF AUDIO AND VIDEO
23 RECORDING AND INFORMATION REGARDING HOW TO REJECT A TRIP;
24 (G) INTEGRATION OF AUDIO AND VIDEO RECORDING INTO A
25 TRANSPORTATION NETWORK COMPANY'S DIGITAL PLATFORM; AND
26 (H) PROHIBITIONS ON CHARGING A FEE OR INCREASING THE COST
27 OF A PREARRANGED RIDE FOR A RIDER SOLELY ON THE BASIS OF THE RIDER
28 OPTING IN TO AUDIO AND VIDEO RECORDING;".
- 29 Page 14, lines 2 and 3 strike "CONDUCTED PURSUANT TO SUBSECTION
30 (7.5)(a) OF THIS SECTION," and substitute "OF EACH PREARRANGED RIDE,".
- 31 Page 14, strike line 8 and substitute "RIDE;".
- 32 Page 14, lines 11 and 12 strike "RIDE PURSUANT TO SUBSECTION (7.5)(a)
33 OF THIS SECTION;" and substitute "RIDE;".
- 34 Strike "(7.5)(a)," and substitute "(7.5)," on: **Page 25**, lines 8 and 24.
