A BILL FOR AN ACT

101 **CONCERNING COMPENSABLE LOSSES UNDER THE "COLORADO CRIME**
102 **VICTIM COMPENSATION ACT" FOR ENROLLED MEMBERS OF A**
103 **FEDERALLY RECOGNIZED TRIBE.**

Bill Summary

The bill allows eligible enrolled members of a federally recognized tribe to receive compensation for traditional Native American healing ceremonies and practices and related expenses under the "Colorado Crime Victim Compensation Act".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-4.1-109, **amend**
3 (1)(i) and (1)(k); and **add** (1)(m) and (1)(n) as follows:

4 **24-4.1-109. Losses compensable.**

5 (1) Losses compensable under this part 1 resulting from death of
6 or injury to a victim include:

7 (i) Reasonable travel expenses for a victim related to funeral,
8 burial, medical care, ~~or~~ mental health counseling, OR TRADITIONAL
9 HEALING CEREMONIES, INCLUDING AS DESCRIBED IN SUBSECTION (1)(m)
10 OF THIS SECTION;

12 (k) Dependent care services; ~~and~~

14 (m) EXPENSES FOR TRADITIONAL NATIVE AMERICAN HEALING
15 CEREMONIES AND PRACTICES FOR PERSONS WHO ARE INDIGENOUS AS
16 DEFINED IN SECTION 24-33.5-2601, INCLUDING, BUT NOT LIMITED TO:

17 (I) TRADITIONAL COUNSELING AND HEALING FROM AN ELDER OR
18 SPIRITUAL HEALER;

19 (II) TRADITIONAL CEREMONIAL PRACTICES;

20 (III) CEREMONIAL BURIALS, INCLUDING CLOTHING FOR THE
21 DECEASED, MEALS, AND OTHER EXPENSES RELATED TO TRADITIONAL
22 GIVEAWAY OR GIFTING PRACTICES;

23 (IV) CHILD CARE DURING BURIAL CEREMONIES; AND

24 (V) REIMBURSEMENT FOR HONORARIA PROVIDED IN CONNECTION
25 WITH CEREMONIAL SERVICES; AND

26 (n) REASONABLE TRAVEL EXPENSES RELATED TO TRADITIONAL

1 NATIVE AMERICAN HEALING CEREMONIES AND PRACTICES, AS DESCRIBED
2 IN SUBSECTION (1)(m) OF THIS SECTION, FOR A VICTIM WHO IS
3 INDIGENOUS, AS DEFINED IN SECTION 24-33.5-2601.

4 **SECTION 2. Act subject to petition - effective date.** This act
5 takes effect at 12:01 a.m. on the day following the expiration of the
6 ninety-day period after final adjournment of the general assembly (August
7 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
8 referendum petition is filed pursuant to section 1 (3) of article V of the
9 state constitution against this act or an item, section, or part of this act
10 within such period, then the act, item, section, or part will not take effect
11 unless approved by the people at the general election to be held in
12 November 2026 and, in such case, will take effect on the date of the
13 official declaration of the vote thereon by the governor.
