the purpose of providing support for the development and funding of an enhanced reimbursement model for nursing facilities that serve residents with behavioral health needs, the state department shall use the gifts, grants, and donations for that purpose. Receiving gifts, grants, and donations for this purpose does not commit the state to an expenditure of general fund money, and the general assembly shall not reduce any appropriation made to the state department for the same purpose.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 25.5-6-211 as
3 follows:

4 **25.5-6-211. Gifts, grants, and donations for enhanced**
5 **reimbursement model for nursing facilities.**

6 (1) IF THE EXECUTIVE DIRECTOR RECEIVES GIFTS, GRANTS, AND
7 DONATIONS FOR THE PURPOSE OF PROVIDING SUPPORT FOR THE
8 DEVELOPMENT AND FUNDING OF AN ENHANCED REIMBURSEMENT MODEL
9 FOR NURSING FACILITIES THAT SERVE RESIDENTS WITH BEHAVIORAL
10 HEALTH NEEDS, THE STATE DEPARTMENT SHALL USE THE GIFTS, GRANTS,
11 AND DONATIONS FOR THAT PURPOSE.

12 (2) UPON REQUEST OF THE JOINT BUDGET COMMITTEE, THE
13 EXECUTIVE DIRECTOR SHALL REPORT TO THE JOINT BUDGET COMMITTEE
14 ON THE USE OF ANY GIFTS, GRANTS, OR DONATIONS RECEIVED PURSUANT
15 TO THIS SECTION.

16 (3) ANY GIFTS, GRANTS, AND DONATIONS RECEIVED PURSUANT TO
17 SUBSECTION (1) OF THIS SECTION DO NOT COMMIT THE STATE TO AN
18 EXPENDITURE OF GENERAL FUND MONEY. THE GENERAL ASSEMBLY SHALL
19 NOT REDUCE AN APPROPRIATION MADE TO THE STATE DEPARTMENT FOR
20 THE SAME PURPOSE BECAUSE OF GIFTS, GRANTS, AND DONATIONS
21 RECEIVED PURSUANT TO SUBSECTION (1) OF THIS SECTION.

22 **SECTION 2. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the
2 ninety-day period after final adjournment of the general assembly (August
3 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
4 referendum petition is filed pursuant to section 1 (3) of article V of the
5 state constitution against this act or an item, section, or part of this act
6 within such period, then the act, item, section, or part will not take effect
7 unless approved by the people at the general election to be held in
8 November 2026 and, in such case, will take effect on the date of the
9 official declaration of the vote thereon by the governor.
