### Summary Information

**Overview.** The bill makes various changes to statute regarding transportation safety, and makes stopping, standing, or parking on a portion of roadway designated as a bike lane a class B traffic infraction.

**Types of impacts.** The bill is projected to affect the following areas on an ongoing basis:

- Minimal State Revenue
- Minimal State Workload
- Local Government

**Appropriations.** No appropriation is required.

## Summary of Legislation

---

The bill makes various changes to statute regarding transportation safety. These changes include:

- clarifying tire, chain, and alternate traction device requirements on a state highway by removing references to four-wheel and all-wheel drive vehicles;
- prohibiting an individual from stopping, standing, or parking on a portion of roadway designated as a bike lane, and making it a class B traffic infraction to do so;
- clarifying language regarding abandoned motor vehicles; and,
- updating statutory references relating to vehicle or traffic collisions or collisions involving other transportation devices.

## Comparable Crime Analysis

---

Legislative Council Staff is required to include certain analysis in the fiscal note for any bill that creates a new crime, or that either reclassifies or creates a new factual basis for an existing crime. This section identifies comparable crimes and discusses assumptions on future conviction rates resulting from the bill.

### Prior Conviction Data

This bill creates a new factual basis for the existing offense of stopping, standing, or parking in a specified or prohibited place, a class B traffic infraction, by adding a bike lane as a specified place. From FY 2022-23 to FY 2024-25, 419 individuals have been convicted and sentenced for this offense. Of the persons convicted, 122 were male, 37 were female, and 260 did not have a gender identified. Demographically, 94 were White, 21 were Black/African American, 9 were Hispanic, 2 were Asian, 72 were classified as "Other," and 221 did not have a race identified. The fiscal note assumes most cases of stopping, standing, or parking in a bike lane will continue to be enforced by local law enforcement, and there will be minimal or no additional case filings or convictions for the new offense under the bill. ## State Revenue and Expenditures

---

The bill may increase workload for trial courts in the Judicial Department if the bill results in more traffic infraction cases, which could also lead to increased revenue from fines and fees, which are subject to TABOR. The fiscal note assumes the bill will result in few additional cases compared to current law, and that any workload or revenue impacts will be minimal.

## Local Government

---

Similar to the state, any increase in revenue and workload from additional class B traffic infractions and municipal court filings is expected to be minimal.

## Effective Date

---

The bill was signed into law by the Governor on May 5, 2026, and takes effect on August 12, 2026, assuming no referendum petition is filed.
