After consideration on the merits, the Committee recommends the following:

HB26-1430 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, after line 12 insert:
- 2 "SECTION 3. In Colorado Revised Statutes, 24-75-219, amend
- 3 (7)(d)(II) as follows:
- 4 **24-75-219. Transfers - transportation - capital construction -**
- 5 **definitions.**
- 6 (7) In addition to any other transfers required by this section:
- 7 (d) (II) On July 1, 2026, the state treasurer shall transfer ~~fifty~~
- 8 ~~million~~ five hundred thousand dollars from the general fund to the state
- 9 highway fund;".
- 10 Renumber succeeding sections accordingly.
- 11 Page 3, line 14, strike "(7)(d)(II), (7)(d)(III)," and substitute "(7)(d)(III)
- 12 and".
- 13 Page 3, strike lines 19 through 21.
- 14 Page 3, line 22, before "(II.5)" insert "(d)".
- 15 Page 4, after line 12 insert:
- 16 "SECTION 5. In Colorado Revised Statutes, 24-75-219, add
- 17 (7)(d)(II.5) as follows:
- 18 **24-75-219. Transfers - transportation - capital construction -**
- 19 **definitions.**
- 20 (7) In addition to any other transfers required by this section:
- 21 (d) (II.5) ON JANUARY 1, 2027, OR AS SOON AS POSSIBLE
- 22 THEREAFTER, THE STATE TREASURER SHALL TRANSFER FIFTY MILLION
- 23 DOLLARS FROM THE GENERAL FUND TO THE STATE HIGHWAY FUND."

1 Renumber succeeding sections accordingly.

2 Page 15, line 11, strike "HOUSE BILL _____," and substitute "HOUSE BILL
3 26-1430,".

4 Page 19, strike line 8 and substitute:

5 "SECTION 16. Effective date. (1) Except as otherwise provided
6 in this section, this act takes effect upon passage.

7 (2) Sections 4 and 6 through 15 of this act take effect only if an".

8 Page 19, after line 14 insert:

9 "(3) Section 5 of this act takes effect only if the initiative that
10 amends the state constitution to change existing law on transportation
11 funding and to increase the amount of state revenue dedicated to road
12 transportation is not approved by the people at the next general election,
13 in which case section 5 takes effect on the date of the official declaration
14 of the vote thereon by the governor or January 1, 2027, whichever is
15 later.".
