I'm also Board President of Colorado Communities for Climate Action, a coalition of 48 local governments representing one third of Colorado's population. We support SB-002 in its amended form as an easy yes and a clear win for affordable energy in Colorado.</p> <p>Nearly 10% of Adams County residents fall below the federal poverty level. For these families, energy costs can suck up 15-25% of their income in many cases. Necessities like heating our homes and cooking our food should not cost Coloradans so much that it becomes a burden. That's why Percentage of Income Payment Plans, or PIPP programs exist. They limit qualifying families' energy bills to a reasonable percentage of their income. This should maintain affordable energy rates for all Coloradans.</p> <p>However, the impact of the PIPP isn't matching the intent. Accessing these programs is unnecessarily difficult, and it's preventing people from getting the assistance they need and deserve. Every utility has a different name for their program and the pathways to enrollment are complicated.
